### Arsenic Mandatory Public Notification Language

The Texas Commission on Environmental Quality (TCEQ) has notified the ELLINGER SEWER AND WSC, TX0750014 that the drinking water being supplied to customers has exceeded the Maximum Contaminant Level (MCL) for arsenic. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for arsenic to be 0.010 milligrams per liter (mg/L) based on running annual average (RAA) and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for arsenic indicates a compliance value in quarter two of 2021 of 0/013 mg/L for EP001. This is not an emergency. However, some people who drink water containing arsenic in excess of the MCL over many years could experience skin damage or problems with their circulatory system and may have increased risk of getting cancer. You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you. We are taking the following actions to address this issue: The Corporation is currently drilling a new well and working on securing funding for an arsenic removal system. This will reduce the amount of arsenic below the MCL and bring the District back into compliance. Please share this information with all people who drink this water, especially those who may not have received this notice directly (people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.
