

KAUFMAN COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

WATER SERVICE

Owner's deposit is \$100.00 (proof of ownership required) Payment required prior to all new service as well as a \$75.00 non-refundable application fee.

Your meter will be read on the 1st Monday of each month. Monthly bills will be sent out around the 15th of each month. Payment in full is due on your account on the 30th of the month. A late charge of 15% will be added if payment is not received by the due date and a delinquent letter for a \$15.00 fee will be mailed. If payment is still not received, a Red Tag will be hung to notify you of possible interruption of service for a \$15.00 fee.

Accounts reaching delinquent status will be subject to a \$30.00 disconnection and \$30 reconnection fee and an additional \$100.00 deposit in order to restore service.

Once service has started if a request is made to temporarily disconnect service a \$30.00 fee will be added to your bill. Additionally, \$30.00 will be added to your bill to resume service.

There is a \$25.00 fee for all returned checks.

If your water service is ever disconnected for non-payment or returned check, payment <u>MUST</u> be made by money order only to restore services.

No letters of credit or payment history will be accepted in lieu of a deposit.
